August 2024 Room Statistics Compared to the Prior Year

Taxable room revenues for the month of August 2024 are \$55,845,967 and above August of the prior year by \$2,269,249 (4.2%). Cash occupied room nights of 331,510 are above prior year by 16,394 (5.2%). Comp occupied room nights of 89,444 are above prior year by 12,609 (16.4%), and 28-day occupied room nights of 86,297 are below prior year by 3,707 (-4.1%). Total occupied rooms for the month of August 2024 (Cash, Comp, 28-day) are 25,296 (5.2%) above the prior year.

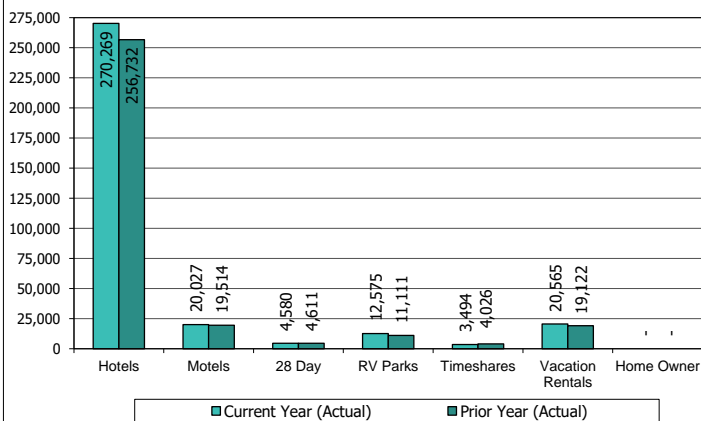
Overall, the Washoe County occupancy percentage of 74.8% for the month is 3.6% above the 72.2% level of the prior year. There were 10,527 (1.6%) more available rooms for the month compared to the prior year.

Overall cash average rates for August 2024 of \$168.46 decreased \$1.56 (-0.9%), compared to \$170.02 for the prior year.

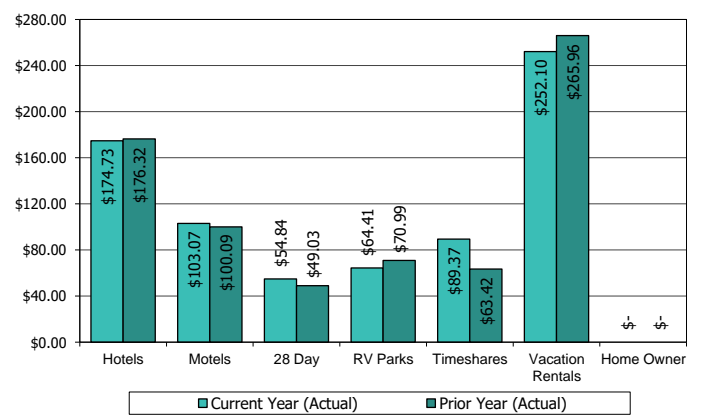
Year-to-date cash occupied room nights of 644,914 are 1,137 (0.2%) above prior year. Cash average rates year-to-date of \$163.18 are \$3.07 (-1.8%) below the prior year. Year-to-date, total taxable room revenues of \$105,234,313 are (-1.7%) below prior year.
